Reading of August 2021 meeting minutes:

Siubhan Fallon moved to approve the 2022 minutes and to waive the reading of the minutes. Mary Boylan seconded the motion and it was carried unanimously.

Reports of Officers and Directors:

Mary Boylan spoke of the purpose for the village annual meeting:

- to elect village directors for open positions
- to elect Oaks representative for the Master Board
- provide owners an opportunity to voice appreciations, concerns and suggestions

Mary also spoke of the Master Board monthly meetings and the annual budget meeting in December. SWII is financially sound, healthy.

Reports of Committees:

Landscaping - The Landscaping Committee meets every other week with the vendors. The committee was pleased with the removing and replacing of shrubs throughout the community.

Roofs /Decks - Decks are on hold while the roof project continues in other villages during the next 4-5 summers. The roof and deck projects may overlap in the future.

Election of Directors for Oaks Board:

Arleen Seabury made a motion to approve the 2022 village board slate remaining in the same four positions for 2023. Sue Halliday, Siubhan Fallon and Alreen Seabury remain in the second year of their term. Bill Karten was re-elected in another 2-year term on the Oaks Village Board as a director.
