**Some routine reminders...**

Out of respect for the neighbors and the rules, we again remind pet owners to be diligent in regards to curbing and picking up after your pets.

For 2010, trash pick ups will be delayed by one day on **Monday, February 15, 2010**, Washington's Birthday; Monday, May 31, 2010, Memorial Day; Monday, July 5, 2010, Independence Day; Monday, September 6, 2010, Labor Day; and Monday, October 11, 2010, Columbus Day.

**All pickups will be delayed one day following the holiday for that week.**

Garbage pails must have lids on them when placed out for disposal on pick up days. Make sure your pail is properly covered and we suggest you take measures to prevent them from blowing away on windy days.
